- » Visual information is also described with text—we use both icons and text for clarity.
- » Existing e-trainings are continuously updated with subtitles to improve accessibility.
- » High-contrast design ensures text is easily readable against the background.
- » We use semantic HTML for headings, lists, and tables to improve screen reader compatibility.
- » Content can be scaled up to 200% without losing quality.
- » Our HTML code is screen reader-friendly, and we continuously refine it as needed.

2. OPERABLE



Our solutions are designed to ensure that individuals with motor impairments or those who don't use a mouse can easily navigate and interact with content. Intuitive operability ensures equal accessibility. Here's how we achieve this:

- » Our User Panel is fully operable without a mouse.
- » Users are given ample time to read and interact with content. Time limits for interactions are minimized and only implemented when necessary to enhance the user interface.
- » Flashing content is avoided, ensuring no element blinks more than three times per second.
- » Meaningful link text is provided to clearly describe the destination or action.
